# Financial Aid Quick Tips

- o 23/24 FAFSA Opened 10/1/2022 (2021 Taxes)
- o FAFSA App offers access to: Grants, Loans, Federal Work Study Funds
- o RSU uses FAFSA application to award all state (OTAG,, OK Promise), federal (PELL, SEOG, Direct Student Loans, Parent Plus Loans), and Institutional aid (Athletic, Endowments)
- o Students will need their own FSA ID number
- o Parents will need their own FSA ID and must sign the students FAFSA Application
- o Soon after application is processed/completed, students can review their SAR (Student Aid Report) to review federal aid amounts @ fafsa.gov
- o Once accepted to RSU, students will receive Estimated\* Financial Aid Award Letter

(\*may not include all awards)

# SCHOLARSHIPS!

- ✓ 150+ Endowment Scholarships awarded yearly (donated by private donors) handled in the Office of Financial Aid
- ✓ Additional Restricted and Unrestricted Private donor scholarships handled by the Offices of Foundations
- ✓ Students must fill out and complete the Free Application for Federal Student Aid (FAFSA) yearly
- ✓ Students must be degree seeking and enrolled full-time at Rogers State University
- ✓ Students must be U.S. citizens or eligible non-citizens
- ✓ RSU revamping Merit Based Scholarships for 23/24

# Oklahoma's Promise

To enroll in the Oklahoma's Promise program, the student must be:

- An Oklahoma resident;
- Enrolled in the eighth, ninth, 10th or 11th grade in an Oklahoma high school (homeschool students must be age 13, 14, 15 or 16); and
- A student whose parents' federal adjusted gross income does not exceed:
  - \$60,000 with 1 or 2 dependent children OR
  - \$70,000 with 3 or 4 dependent children OR
  - \$80,000 with 5 or more dependent children.
- Pay tuition (only). RSU Tuition Rate is \$162 per unit\*
- Up to Bachelor's Degree (129 Units)
- RSU Provides \$2000 per year housing waiver (Does not cover summer semester)
- OK Promise Eligibility List provided to RSU after FAFSA completion
- Covers degree contributing classes only
- OK Promise does not cover summer semester directly after graduation

Must meet RSU Satisfactory Academic Progress (SAP) Policy
